**MINUTES OF A REGULAR MEETING OF THE CITY COUNCIL
December 3, 2007**

The City Council of Red Bay met in a regular scheduled meeting on Monday, December 3, 2007 at 7:30 p.m. The meeting time was changed to give the mayor and council time to return from the annual Christmas Parade. The meeting was held in the Red Bay City Hall Council Room, 203 4th Ave. S.E., Red Bay, AL

Present and presiding was Mayor Jeff Reid. Council members present were Bobby Nelson, Pat Hammock, Rayford Seahorn, Ann Wilkins and Ricky Holland.

Linda B. Holcomb, City Clerk, was present and recording.

Also present were Fire Chief Bud Strickland, Police Chief Pat Creel, City Supervisor Wayne Sims, Vista III Media representatives, Metro Cast Communications representatives, and Patricia Henley.

Pastor Greg Philamlee of New Union Baptist Church led the Invocation.

Pat Hammock led the Allegiance to the Flag.

Fire Chief Bud Strickland reported that all fire trucks were in service.

Police Chief Pat Creel stated that there was a large crowd that attended the open house on Sunday December 2, 2007 for the new city hall and the new police station.

Rita Page was recognized and thanked for providing interior decorating services for the two new municipal buildings.

Patricia Henley addressed the council concerning an accident that occurred on September 17, 2007 involving a vehicle driven by her daughter and a Red Bay police vehicle. Mayor Reid stated that the accident is still under investigation by the city's insurance carrier Alabama Municipal Insurance Corporation.

The council was addressed by representatives of Metro Cast Communications and Vista III Media concerning Vista III Media's sell to Metro Cast Communications of Mississippi. The representatives answered questions from the council. Ricky Holland made a motion to adopt **Resolution #07-11-05**, seconded by Bobby Nelson, unanimously passed. **Attachment A**

Bobby Nelson made a motion to accept the low bid of nineteen thousand four hundred and seventy dollars (\$19,470.00) for the concrete pad on Skate Park Project #07-LW-908

Pat Hammock made a motion to accept the only bid received for equipment, seventy-thousand four hundred sixty-six dollars and twenty-four cents (\$70,466.24) and installation, seven thousand forty-six dollars and twenty-two cents (\$7046.22), from American Ramp Company. 


Pat Hammock made a motion to approve the bills, seconded by Ricky Holland, unanimously passed.
