Linda B. Holcomb, City Clerk, was present and recording.


There was no call to order.

David Martin seconded the motion, unanimously passed.



Ann Wilkins made a motion to approve the bills for payment, seconded by David Martin, unanimously passed.


Bobby Nelson made a motion to approve the workshop minutes and the council minutes for August 4, 2008, Ricky Holland seconded the motion, unanimously passed.
