**MINUTES OF A CALLED MEETING
RED BAY CITY COUNCIL
September 2, 2008**

The City Council of Red Bay met in a **Called** Meeting September 2, 2008, 11:45 a.m. The meeting was held in the Red Bay City Hall Council Room, 203 4th Ave. S.E., Red Bay, AL.

Present and presiding was Mayor Jeff Reid. Council Members present were David Martin, Ann Wilkins and Ricky Holland.

Absent were Council Members Bobby Nelson and Pat Hammock.

Linda B. Holcomb, City Clerk, was present and recording.

Mayor Jeff Reid stated that the purpose of the **Called** Meeting was to comply with Section 11-46-46, of the Code of Alabama of 1975 as amended, concerning the Certification of the Municipal Election held on August 26, 2008.

Mayor Reid announced individual vote counts for each candidate for standard machine votes, absentee votes, and hand counted votes.

Mayor Reid then called for the **Provisional Ballot Box**. He opened the box which contained two provisional ballots approved by the Franklin County Board of Registrars. He opened each ballot and announced the votes marked thereon.

After all votes were totaled Mayor Reid announced the total votes received by each candidate. The vote totals were then placed by each candidates name in Resolution #08-09-02.

Mayor Jeff Reid read Resolution **#08-09-02 Canvassing Election Results** in its entirety. Ann Wilkins made a motion to adopt Resolution #08-09-02, seconded by Ricky Holland. The roll call votes was as follows: David Martin "yeas", Ann Wilkins "yeas", and Ricky Holland "yeas". The resolution was adopted as read. **(Attachment A)**
